

## Sage BusinessWorks Release Notes: V2010 SP5

The following is a summary of changes included in the Sage BusinessWorks V2010 service pack (SP5) release. If a change affects more than one module, it is listed under the System Wide heading.

### Sage Software Online Knowledge Base Articles

#### System Manager

Emailing Reports on Windows 7 now accepts valid email addresses
The error '12/30/1899 is not a valid date' no longer occurs when using dashes as date separator in Regional Settings
Shortcut order is now saved properly when exiting Sage BusinessWorks
"Copy From" button within Custom Reports now works correctly when selected at a client workstation
Registration reminder now recognizes 2 or 4 digit years based on Regional Settings
Backup Utility now backs up files marked for compression

#### Accounts Receivable

Transactions / Bank Deposits
The invoice number for 'CASH' customer now displays in the Bank Deposits window

Statements / Print Statements
Statement balance is now correct when a customer has a prepaid invoice that has been voided
Charges column and statement balance are now correct when duplicate invoice numbers exist

#### Order Entry

Utilites / Ship To Addresses / Maintain
Zip code lookup no longer returns an error when clicked prior to selecting a Ship To Address

**Invoices / Returns**

Credit memos entered with an excess amount applied now posts correctly to the GL

**Invoices / Void Invoices**

An error no longer occurs when attempting to void a duplicate invoice number if the other invoice had already been voided

**Orders / Maintain Sales Orders**

An error which created a blank part ID no longer occurs when editing a comment on a partially invoiced Sales Order

Duplicate line items are no longer created when editing a line item description on a partially invoiced Sales Order

**Payroll****Taxes / Enhanced Tax Reporting and E-Filing**

Payroll checks with a check date in the current quarter and pay period start and end dates in the next quarter now appear correctly on the 941 report

**Reports / Employee Reports / Employee lists / Employee 401k List**

Employee totals on the Employee 401k list are now correct for the first employee listed on additional pages when the report generates more than one page

Invoices imported using BWAccess now post correctly when using multiple sales accounts

Create GL Data Files is no longer slow when attempting to recreate GL data files

The Cash Account selection is now available when posting an Invoice Return

Release date on Imported Sales Orders no longer reverts to Required Date

Invoices / Direct Invoicing

Assigned serial numbers no longer disappear on sales order or invoice line items

Accounts / Enter Initial Account Balances

Save no longer locks up when Chart of Accounts is out of balance

### ***BWAccess***

Importing AR invoices thru BWAccess no longer creates invalid sales accounts

California Effective 11/1/09 Withholding tables revised

## *Order Entry*

### Orders / Maintain Sales Orders

Line items on sales orders can now be deleted if the sales order originated from a copy of an order that was previously invoiced

## *System Manager*

### Dbregister

Dbregister now uses administrator login credentials that were entered at time of client installation
